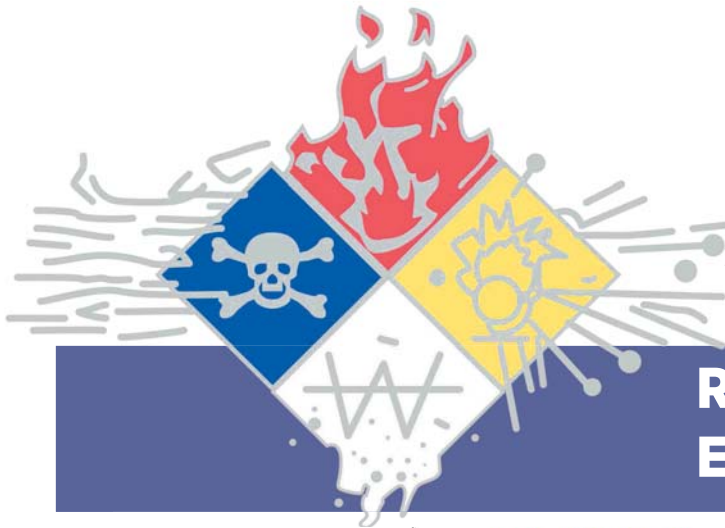

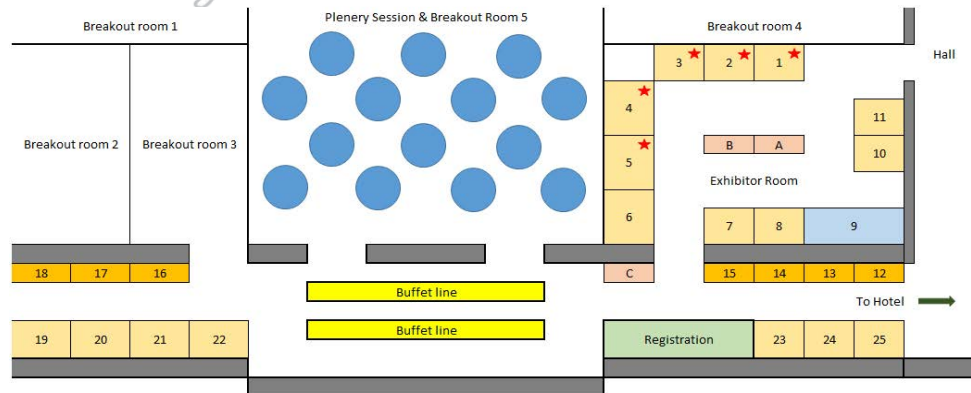

SETUP AND TEARDOWN

Exhibit setup will be from 1:00 PM to 5:00 PM on Tuesday, June 6. All exhibits must be removed by no later than 12:00 PM on Friday, June 9.

BOOTH DESCRIPTION/COSTS

Exhibitors are able to select their booth location and type subject to availability.

Each booth will consist of:

- 1 - 6' x 30" table covered and skirted
- 1 - waste basket
- Electrical Service (except where noted on diagram) - 120 volt/5 AMP

Booths will also have 1 or 2 chairs depending on booth type

Booth Costs:

- Standard: \$750
- Wall: \$500

APPLICATION

Payment for the booth and a description of the exhibit must accompany registration. Each Booth Registration includes one event registration.

CLEANLINESS

A clean building will be furnished at the start of each day. The exhibitors shall maintain and keep in good order their respective exhibit spaces.

Smoking will not be allowed in the venue.

SALES

Retail sales and the development of sales leads are allowed at the conference. Exhibitors are responsible for applicable sales licenses and taxes.

Sales of food or beverages and games of chance, lotteries, etc. are prohibited.

SHIPPING

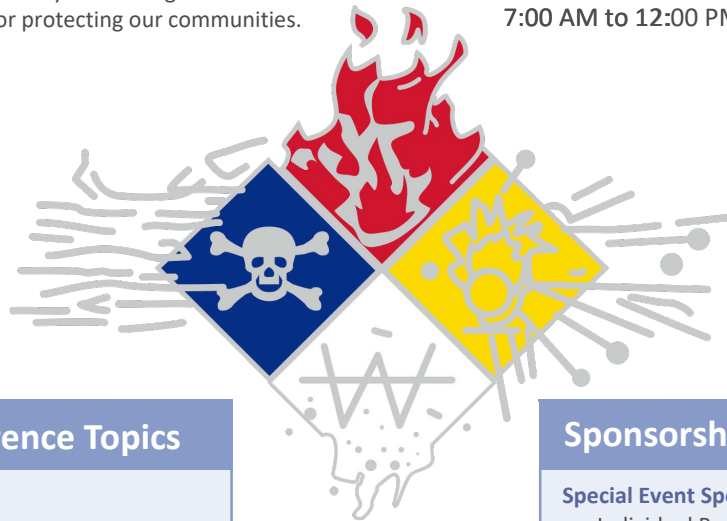
